We will also discuss post injury protocol as well as useful safety and accident prevention information. Spotlight on Public Employers

CompManagement works with more public employers (cities, counties, villages, schools, water conservancies, libraries, townships, etc.) than any other third party administrator (TPA) in Ohio which allows us to be in a unique position to provide expert advice. We will review the dates that are important for public employers and look at unique areas of coverage such as sending your first responders to another state in times of emergency. We will examine the specific steps required to provide coverage to your volunteers and identify items you should consider when determining whether to obtain this additional coverage. Claim allowance is another area that impacts public employers differently and we will discuss exposure claims and fire fighter cancer claims. The session will also touch on things to consider regarding wage continuation as addressed in your policies and union agreements. Finally, we will discuss cost relief and assistance available through motor vehicle accident subrogation and Safety Intervention Grants. The options include Administrative rebates, Safety Council rebates, an Industry Specific bonus, a Drug-Free Safety incentive and a Transitional Work Grant and bonus. This session will define the individual programs, outline the available discounts/rebates associated with each and navigate the requirements, as well as the compatibility and deadlines.
